3.	I FREELY ACCEPT and FULLY ASSUME all RESPONSIBILITY for the inherent Risks and the possibility of person injury, death, property damage or loss resulting from my participation in Equine Activities.	
4.	I ACKNOWLEDGE that it remains my Sole Responsibility to act in such a manner as to be responsible for my own safety and to participate in Equine Activities Within My Own Limits.	
5.	In addition to consideration given for me to participate in Equine Activities, I and my heirs, executors, administrators and assigns (collectively my "Legal Representatives") agree:	

- To Waive all Claims that I or the participant might have against North Stone Farm; and
- To Release North Stone Farm from ANY and ALL LIABILITY for any loss, damages, injury or expense that I or my Legal Representatives might suffer as a result of the participation due to any cause whatsoever including any NEGLIGENCE on the part of North Stone Farm; and
- To HOLD HARMLESS and INDEMNIFY North Stone Farm from any and all liability for property damage or personal injury to any third party which might result from participating in Equine Activities.
