



## NORTH STONE FARM RIDING CAMP REGISTRATION FORM

Activities include English horseback riding and trail riding; arts and crafts; stable management (feeding, grooming, handling); games and sports; educational activities and swimming (weather and season permitting). North Stone Farm staff is First Aid certified and has extensive experience hosting camps and working with children. Children are under staff supervision at all times. We are proud to offer a safe environment for children to play, ride and learn about horses.

North Stone Farm provides all necessary equipment for the horse. Children need to wear jeans, leggings or riding breeches, boots with a heel (i.e. a rubber rain boot) and an ASTM/SEI approved RIDING helmet. Bike helmets and other sport helmets do not provide sufficient protection in the event of a fall. Helmets and inexpensive rubber boots may be purchased at Ritchies Feed and Seed or any Tack Shop. We have some helmets available, though for proper fit and hygienic reasons we strongly recommend you purchase your own.

***Registration and payment in full are due 2 weeks prior to the beginning of the camp. No refunds.***

Campers will need to bring their own lunches daily and we ask that you make an effort to make them litter-less. Any garbage brought to the farm will need to be taken home with you at day's end.

We do not encourage bringing expensive electronic equipment such as iPods, Gameboys, cellphones, etc. and North Stone Farm cannot be held responsible for loss or damage to such items. Do not send camper with computers or other delicate electronic equipment, expensive jewelry or inappropriate clothes. North Stone Farm is not responsible for any personal items belonging to campers.

### **Items needed for Camp:**

1. Riding boots: English riding paddock+ boots or tall boots are best. Boots must have a low heel, and cover the ankle. (Tennis Shoes are not acceptable for riding)
2. All campers need to arrive in long pants and boots.
3. Campers may bring a change of clothes, such as shorts and tennis shoes; to change into after work with the horses is completed.
4. Camper will be responsible for their own lunch each day.
5. Swimming suit and towel are needed if you would like to swim (weather and season permitting).
6. A blank t-shirt suitable for decorating/painting during arts and crafts.

  - The potential for other participant(s) to act in a negligent manner that might contribute to injury to themselves or others, such as failing to act within their ability or to maintain control over any horse.
  
- \_\_\_\_\_ 3. **I FREELY ACCEPT and FULLY ASSUME all RESPONSIBILITY** for the inherent Risks and the possibility of person injury, death, property damage or loss resulting from my participation in Equine Activities.
  
- \_\_\_\_\_ 4. **I ACKNOWLEDGE** that it remains my **Sole Responsibility** to act in such a manner as to be responsible for my own safety and to participate in Equine Activities **Within My Own Limits**.
  
- \_\_\_\_\_ 5. **In addition to consideration given for me to participate in Equine Activities, I and my heirs, executors, administrators and assigns (collectively my "Legal Representatives") agree:**

- **To Waive all Claims** that I or the participant might have against North Stone Farm; and
- **To Release** North Stone Farm from ANY and ALL LIABILITY for any loss, damages, injury or expense that I or my Legal Representatives might suffer as a result of the participation due to any cause whatsoever including any **NEGLIGENCE on the part of North Stone Farm**; and
- **To HOLD HARMLESS and INDEMNIFY North Stone Farm** from any and all liability for property damage or personal injury to any third party which might result from participating in Equine Activities.
